Once that goal is set on false accusations and criticism, the goal has been compromised, and the integrity of our Village is at risk.

COMMUNITY ASSOCIATION UPDATE - COVID-19 LIABILITY IMMUNITY

WHAT TO WATCH FOR ...

COVID-19 LIABILITY IMMUNITY STATE & FEDERAL OUTLOOK

As New Jersey's private and public sectors reopen at various speeds, policymakers in Trenton and Washington DC are considering a host of bills that focus on liability protections associated with legal risks of COVID-19. Generally speaking, state and federal COVID-19 liability immunity policy proposals run the gamut from broad blanket lawsuit immunity to more narrowly defined protections; such as "safe harbor" legislation that seeks to protect private/public sector entities where these entities have followed the COVID-19 guidance available for keeping employees, customers, or visitors safe. This *Community Update* takes a macro view of ongoing developments in Trenton and Washington DC with respect to COVID-19 liability immunity and what it may mean for our community association clients.

AN EYE ON TRENTON

The COVID-19 liability immunity debate is ongoing in the halls of the State House. Several bills have been introduced including the following:

A4440/A4377 /S2628/S2634- Narrow immunity for entities and colleges	A4426-Narrow immunity for schools	A4408Broad immunity for higher education	
A4388- Broad immunity for employers	A4377-Narrow immunity for Entities	A4390/S2695-Broad immunity for age restricted associations	*

Of note is the Age Restricted Immunity Bill (A4390/S2695), which sets forth in part:

"Any association of an age-restricted planned real estate development, and any members, employees, and agents thereof, shall not be liable for any civil damages for injury or death caused by an exposure to COVID-19, a related viral strain, or a disease caused by either one, alleged to have been sustained as a result of an act or omission by the age-restricted planned real estate development association, or any members, employees, or agents thereof, in the course of managing or maintaining the common elements and facilities of the age-restricted planned real estate development

What to Watch For: A4390/S2695 should be of interest to our community association clients. The bill was introduced on July 16, 2020 and is currently before respective judiciary committees where it will undergo legal scrutiny. As envisioned, the bills carry broad protections for senior planned real estate development associations against damages caused by an exposure to COVID-19 as a result of the act or omission in the course of managing or maintaining the common elements and facilities of the age-restricted association. The bill, as currently written, would only apply to "age-restricted" communities, but the prospect of added amendments to broadly include all common interest communities will be high on our watchlist.

AN EYE ON WASHINGTON

The prospect of broad, federal COVID-19 liability immunity covering wide sectors for private/public entities is less certain. There is liability immunity legislation in place pertaining to matters previous to the COVID-19 pandemic, but the enactment of generalized, COVID-19 liability immunity legislation remains evolutionary and like most things in Washington, highly partisan. The recent, House passed *Health and Economic Omnibus Emergency Solutions (HEROES)* Act does not include blanket immunity provisions, and instead relies on establishing mandatory protocols regarding workplace safety, as one example. Policymakers in the Senate have called for the inclusion of broader liability protections, especially for the private sector and businesses, but while there have been many proposals, meaningful immunity protections have yet to surface.

NAVY DAY Wilkipedia

In the United States, the Navy League of the United States, organized the first Navy Day in 1922, holding it on October 27 because it was the birthday of the 26th President Theodore Roosevelt (1859-1919, served (1901-1909, who was a naval enthusiast/promoter of sea power and former assistant Secretary of the Navy just before the Spanish-American War of 1898. Although meeting with mixed reviews the first year, in 1923 over 50 major cities participated, and the United States Navy sent a number of its ships to various port cities for the occasion. The 1945 Navy Day was an especially large celebration, with 33rd President Harry S. Truman (1884-1972, served 1945-1953), reviewing the returning home American fleet in New York Harbor after victory in World War II.

In 1949, Louis A. Johnson, (1891-1966, served 1949-1950), second Secretary of the newly merged and created Department of Defense, directed that the U.S. Navy's participation occur on newly established Armed Forces for the unified/ coordinated uniformed services in May, although as a private civilian organization, the Navy League was not affected by this directive, and continued to organize separate Navy Day celebrations as before. In the 1970s, historical research found that the "birthday" of the earlier Continental Navy during the American Revolutionary War (1775-1783), was determined to be October 13, 1775, and so Chief of Naval Operations Admiral Elmo R. Zumwalt worked with the Navy League to define October 13th as the new date of Navy Day. However, Navy Day in the United States is still largely recognized as October 27th.
