While the focus of our concern is the safety of our residents, we are also reminded of our responsibility to protect our Village financially. Our safety is first, but financial protection is vital to our Community.





Election Committee

From the State of New Jersey

Effective Friday, March 19th, restaurants, recreational and amusement businesses, gyms and fitness centers, and barber shops, salons, and other personal care businesses can increase indoor capacity to 50 percent. In addition, the general outdoor gathering limit will increase to a maximum of 50 people and the general indoor gathering limit will increase to a maximum of 25 people.

These businesses must continue to abide by current health and safety protocols, including face covering and physical distancing requirements.

Indoor Gatherings

The general indoor gathering limit will increase from 10 people to 25 people.

Indoor gatherings that currently have a higher limit — religious services or ceremonies, political events, weddings, funerals, memorial services, or performances — will remain unchanged.

Outdoor Gatherings

The general outdoor gathering limit will increase from 25 people to 50 people.

Outdoor gatherings that are religious services or ceremonies, political events, weddings, funerals or memorial services will remain unchanged by the Order.

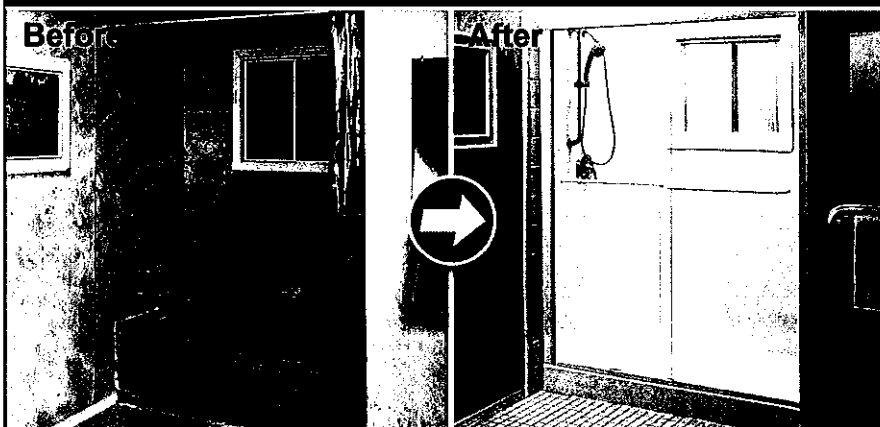

COVID 19 TESTING ONLY

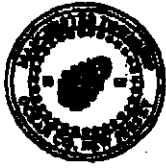
On April 20th Ridgewood Laboratory will be coming to your community for COVID-19. Testing will take place from 10am-3pm.

All that is required is for you to bring the following items:

- Drivers license
- Insurance card(s) (primary and secondary)
- List of your medications (if any)
- List of your surgeries (if any)
- Pen (if available)

The entire testing process will be done from the comfort of your car. A team member will come up to your window and ask for your driver's license, insurance card(s), and phone number. Once your insurance is verified you will then speak to our PA (Physician's Assistant) where she will ask you about your medical history, and determine if it is medically necessary to be tested or not. When you are finished speaking with the PA you will then be tested for COVID-19.

THERE IS NO OUT OF POCKET COST AND WE ACCEPT ALL INSURANCE BUT IF YOU HAVE NO INSURANCE, PLEASE BRING YOUR SOCIAL SECURITY CARD AND WE WILL BILL THE CARES ACT.

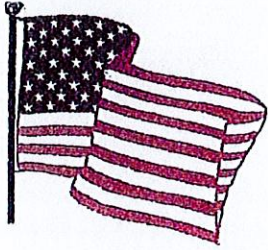

The reason for this is obvious “membership is the lifeblood of The American Legion.” Without members there would be no Legion programs. Without members we would have no voice on Capital Hill. Without members there would be no accomplishment in assistance and support to veterans, their families, the community, state and nation. But, The American Legion has recorded consistent accomplishments for veterans and their families since 1919.

It is often emphasized, “It is not the price you pay to belong, but the price you paid to be eligible to belong.” Often times our members are hesitant to ask a veteran to join The American Legion because we are asking the veteran for his money and his time. Do you not feel, as a Legionnaire, that time and money will be well spent in advancing the many and various programs of the American Legion? Don't be hesitant or apologetic, we ask you to join.

As our numbers grow, so does political power. As years pass the term “veteran” is being forgotten. As an organization of devoted men and women veterans, we must be willing to commit ourselves to turning this present course around and stand by our slogan.... “We remember the Vet so that no one forgets.”

If you have served federal active duty in the United States Armed Forces since December 7, 1941, and have been honorably discharged or are still serving - you are eligible for membership in The American Legion!

Because eligibility dates remain open, all active duty members of the U.S. Armed Forces are eligible to join The American Legion at this time, until the date of the end of hostilities as determined by the government of the United States. **U.S. Merchant Marine eligible only from December 7, 1941 to December 31, 1946 (WWII)**

Because of the pandemic we are currently not meeting normally. We meet on the first Tuesday of the month, except July and August, at 10:00AM in Crestwood Village VII, Annex, 1 Falmouth Avenue just off of Station Road in Whiting. Or just join us at one of our meetings over a cup of coffee and meet with fellow veterans.

If you want to join or transfer from another Post or holding Post 1000 we have the necessary paper work, our dues are only \$ 35.00/year. The Post will need a copy of your DD 214 to join. If you have any other questions, the Commander can be reached at 732-350-6832 between 5:00-6:00 P.M. Arthur M. Wright, Jr.

2nd Notice - Post Officers for 2021-2022 year are due. If any member desires to become an Officer of the Post, all positions are open, Commander, Vice Commanders, Adjutant, Judge Advocate, Chaplain, Service Officer, Treasurer, Sgt-At-Arms, please let the Commander know.
