# WHITING VILLAGE AT CRESTWOOD COMM. ASSOC. INC. OPEN MEETING JULY 20 2023

Meeting opened at 10 AM; all Trustees present except Ed Espositio. Pledge of Allegiance performed.

Secretary asked Board for permission to omit reading June Sunshine Meeting Minutes, since said Minutes are available to residents on the Village website. Copies were also provided to attendees at today's meeting. Board agreed, and proceeded to vote to accept the June Minutes.

Secretary read a note outlining upcoming events & various items of interest and information to the residents; please see attached. Agenda for this meeting was available for all attendees, and it informed residents that this meeting was primarily for the presentation of Village financial information by our Accountant & our Treasurer.

Our Treasurer, Howard Snyder, explained the financial improvements this Board has accomplished; he explained in detail the various CD purchases the Board has approved, which altogether will realize approximately \$40,000 in interest this fiscal year. Howard reminded the residents that amount is a vast improvement over what former Boards had done for the financial health of the village.

Our Accountant, Skip, then offered an in-depth explanation of our audit, page by page. There were copies of the financial audit available for attendees at todays meeting & residents were able to follow along page by page as Skip explained all the various aspects of the budget and the audit. He ended by informing the residents that the audit report was quite positive in its opinion of the fiduciary actions of the present Board. He opened the floor for questions.

Residents had a few questions to ask, some of which were not related directly to the Village's financial health: one resident asked the Board to reassess their decision to refuse to join Firewise. Another asked for specific information on our Village H/O insurance, and what was actually covered by the basic Village policy.

Meeting closed at approximately 12 noon. Next Sunshine, or Open Meeting, is scheduled August 17 at 10 AM. There is a Quarterly Meeting scheduled for 10 AM August 8 2023.
