The GAG order was lifted and the Board of Trustees received a copy of said order prepared by the court, and signed by the Honorable Mark A. Troncone from our Attorney after 4 p.m. on Thursday, July 18th. Therefore, we are allowed to speak and residents were informed of the following at the July Sunshine meeting:

- 1. At no time were any members degraded.
- 2. The option of an ADR could have been used before taking claims to a court in the State of New Jersey saving us thousands of dollars.
- 3. Residents were informed that four (4) of the trustees are running again in September's election. The board has held strong and will continue to do our best for both the residents and our community.

Our struggle has been on behalf of this community to keep our expenses down and pay for this lawsuit. To date, the association has paid the following for this litigation:


