Reference Code Explanations:

1. A copy of the brochure showing the item to be installed, if available.
2. Color must complement overall color scheme of home.
3. All required permits must be issued and properly displayed at the residence by the contractor prior to the start of any construction. (Violation of this requirement will result in a fine being assessed to the homeowner.)
4. All installations must be done by a fully licensed and insured contractor. A copy of the contractor's current insurance must be on file in the Village Office before an approval of the request will be considered by the Trustees.
5. It is recommended that full glass storm doors NOT be installed due to excess heat buildup problems which cause warping to the interior door.
6. All installation of expansions must be done by a fully licensed and insured contractor. Expansion must conform with approved driveway material. (Concrete or Asphalt)
7. Storage bin can be located on either side or rear of home. CANNOT be located in front of the home.
8. Submit drawing & survey. Call New Jersey ONE CALL 1800-272-1000 before you dig. Does not apply to purgula.
9. Proof of insurance with fireplace/electric charging station on homeowners insurance policy.
10. Permit from Manchester Township must be obtained.
11. Obtain a survey.
